Regulations

To the extent Applicant's credit request is approved, the following regulations govern the extension of credit to customers of Artisan Technology Group:

1. Standard selling terms are net 30 days. Requests for special terms must be made through Artisan Technology Group's Credit Department. A service charge of 1 1/2% per month (18% per year) will be assessed on past due accounts.
2. No open account shipments will be made that will cause an account to exceed the credit limit established by Artisan Technology Group.
3. Artisan Technology Group may request from time to time reasonable evidence of continuing credit worthiness after an account has been opened. Such evidence will usually be in form of annual financial statements, trade references, and bank references, but Artisan Technology Group reserves the right to require additional information in its sole discretion.
4. Changes in the Applicant's business status or structure must be reported promptly to Artisan Technology Group since the original credit applicants will remain liable for payment for shipments made to a business until such notification is received. Formal notification of changes such as incorporation, changes in ownership or other restructuring that may alter the liability of a customer or its owner must be received in writing and will not be effective until received and approved by Artisan Technology Group.
5. In the event of non-payment of an obligation due Artisan Technology Group and the institution of collection and legal proceedings, Applicant shall pay any and all collection costs incurred by Artisan Technology Group in collecting amounts owed to Artisan Technology Group, including, without limitation, attorney's fees together with court costs and accrued service charges from the date due until the date of final payment.
6. In consideration for Artisan Technology Group's review of this Application and any credit subsequently made available to Applicant by Artisan Technology Group, the Continuing Guaranty below shall be executed and delivered with this Application and remain in full force and effect during any extension of credit made by Artisan Technology Group to Applicant.

The undersigned warrants that he or she is an officer or principal of the company that is requesting credit from Artisan Technology Group, has read and understands the preceding Credit Regulations and agrees to cause such company to abide by the terms and conditions outlined in said regulations. Authorization is hereby given to Artisan Technology Group to investigate the references herein listed and any other credit information available to Artisan Technology Group pertaining to Applicant. The undersigned hereby certifies that all of the statements and information contained herein are true and correct and have been supplied for the purpose of inducing Artisan Technology Group to grant the herein applied for credit.
